

# COVERING CONDITIONS 2021

Kveikur frá Strangarlaek & Styrkur frá Leysingjastöðum

The mare should be a pure-bred Icelandic horse, registered in WorldFengur by FEIF. The mare-owner should hand in the passport of the mare upon arrival of the mare. The passport will be kept by Hengstenhouderij van Nunen and will be returned when the mare is picked up.

The mare must be declared healthy and in good shape to be a breeding mare. The mare must be vaccinated according to the rules of FEIF. She must be dewormed less than a week before she is brought. The mare must have newly trimmed hooves and must be brought without shoes.

For both stallions we charged a non refundable deposit as registration. The registration of the mare is only valid when the deposit has been paid. When the mare is pregnant the owner will get an invoice with the additional studfee, stable costs and veterinarian costs.

The mare owner will pay daily stable costs. For mares that are standing in a group on a field the daily costs will be 8,- euros per day. For mares with a foal on foot the daily costs will be 10,- euro per day. For mares standing alone in a paddock the price will be 12,- per day. For mares standing in a paddock with a foal on foot the price will be 14,- per day. For mares with summer eczema the price will be 5,- euros per treatment (upon the owner's request). The costs for a covering coupon will be 14,- euros per mare, and has to be paid by the mare owner. All prices are including VAT.

The mare will only be accepted when a bacteriologic test of the cervix with a negative result is presented. This test cannot be older than 28 days before arrival of the mare.

We will have fresh semen of Kveikur & Styrkur, but we do not send semen. That means every mare who has to be inseminated has to come to Hengstenhouderij Van Nunen. Next to that, our own veterinarian will scan the mare for insemination. Because we want to control the process ourselves.

The total studfee of Kveikur is: 2200,- euros. With a non refundable deposit of €300,- euros. as registration. Exclusive VAT 25%:

The total studfee of Styrkur is: €1800,- euros. with a non refundable deposit of €300,- euros as registration. Exclusive VAT 25%

The deposit for both stallions is: €300,- this is including the shipping costs of the semen for the first time. If the mare is not pregnant the shipping costs will be charged again.

Hengstenhouderij van Nunen does not accept any liability for damage, illness / and injury to people, animals, means of transport or otherwise. Horses are treated at the owner's risk. The mare owner is responsible for all costs.

If afterwards the mare turns out not to be pregnant or the foal died within 24 hours after birth. Then the mare owner is entitled to a new insemination in the same year or in 2022 for the same mare, or another mare from the same owner. The mare owner pays then only for the stable costs and veterinary costs.

It can happen that Kveikur and/or Styrkur have to perform at a competition or that they are not fit. Unfortunately it can happen that we have less semen in stock.

We would like to know when the mare is expected to come and inseminate. Because of the limited stock, please indicate when registering. When we have a limited stock we will follow this rule: the first mare who is registered has the first right to be inseminated.
